Instructions for patients receiving treatment for Alopecia Areata

- Treatment area should be covered for 24 hours following treatment; area should be kept covered from all light, this could be best achieved by wearing a hat, scarf or wig. UV light is known to degrade DPC causing it spread to other areas of skin.
- Avoid touching the treatment area for 48 hours after treatment. If you do touch the area, wash your hands immediately with soap and water.
- Avoid washing the scalp for 48 hours after treatment.
- If the treatment area becomes very hot, red or itchy, apply the steroid cream you have prescribed by your doctor that you will have been given prior to your treatment.
- If you are experiencing a severe/ unbearable reaction (blistering, severe redness or irritation) following treatment application, please wash the DPC solution off with soap and water and contact the Dermatology Department for further advice.
- Female patients must avoid pregnancy during treatment and for six months following treatment.
